Call for Papers

The Institute of Administrative Sciences (IAS), University of the Punjab and the South Asian Network for Public Administration (SANPA) are pleased to announce their upcoming International Conference on "Local Realities and Regional Futures: Transforming Public Administration and Management in South Asia". The conference seeks to bring together scholars, practitioners, policymakers, and students from across South Asia and beyond to engage in thoughtful dialogue, research exchange, and knowledge sharing around the critical transformations shaping the region.

South Asia stands at a pivotal juncture. Objectives

- To examine emerging challenges and innovations in digital transformation, AI, and crisis governance for more resilient and inclusive public service delivery.
- To foster dialogue on gender, equity, and inclusion in public administration across South Asia, with a focus on marginalized and underrepresented groups.
- To investigate the role of decentralization and local governance in strengthening democratic accountability and participatory governance.
- To identify and discuss innovative and contextually appropriate governance models, strategies, and reforms that reflect indigenous realities and respond to contemporary issues
- To strengthen the South Asian research community by promoting the exchange of ideas, joint research initiatives, and
 institutional partnerships across countries

Outcomes

- A set of context-sensitive policy recommendations and frameworks to guide locally grounded public administration reforms in South Asia.
- Enhanced regional academic and practitioner networks, including potential partnerships between universities, think tanks, and civil society organizations.
- A published volume or conference proceedings featuring selected peer-reviewed papers that contribute to the discourse on indigenization and transformation of governance in South Asia.

- A regional research agenda under SANPA promotes epistemic diversity, digital inclusion, and innovative governance models
- Increased visibility and legitimacy of South Asian perspectives in global public administration discourse, advocating for epistemic diversity and locally grounded solutions.

Subthemes

Potential avenues of exploration include, but are not limited to the following themes:

Subtheme 1: Artificial Intelligence (AI) and E-Governance for Public Services

The advent of Artificial Intelligence (AI) and the rise of e-governance present unprecedented opportunities to revolutionize public service delivery, enhance operational efficiency, and improve citizen engagement. This subtheme invites papers that explore the synergistic application, impact, and ethical considerations of AI and digital governance in various aspects of public services in South Asia, including but not limited to:

- Al-driven governance, digital policy formulation, and decision support systems
- Smart city initiatives integrating AI and e-governance platforms
- Al and e-governance solutions for healthcare, education, and social welfare
- Al in digital law enforcement, judicial processes, and regulatory compliance
- Ethical implications and governance frameworks for Al and e-governance in the public sector
- Addressing algorithmic bias, data privacy, and ensuring inclusivity in Al-driven e-governance
- The role of AI in enhancing transparency, accountability, and citizen trust through digital public services

Subtheme 2: Civil Service Reforms

A robust and efficient civil service is the backbone of effective governance. This theme seeks to examine the challenges and opportunities in reforming civil services across South Asian nations to enhance their performance, responsiveness, and integrity. Submissions are encouraged on topics such as:

- Merit-based recruitment and promotion systems
- Capacity building and professional development
- Performance management and accountability mechanisms
- Digitalization and modernization of civil service processes
- Addressing corruption and promoting ethical conduct
- The impact of political interference on civil service effectiveness
- Comparative analysis of civil service reforms in South Asian countries

Subtheme 3: South Asian Relations in a Changing Landscape

The geopolitical landscape is constantly evolving, presenting both challenges and opportunities for inter-state relations in South Asia. This theme invites papers that analyze the dynamics of South Asian relations in the context of global and regional shifts, including:

- Bilateral and multilateral relations among South Asian nations
- The impact of global power dynamics on regional cooperation
- Trade, connectivity, and economic integration in South Asia
- Addressing regional security challenges and conflicts
- The role of non-state actors and transnational issues
- Cultural exchange and people-to-people connectivity
- The impact of climate change on regional stability and cooperation

Subtheme 4: Indigenizing Governance: Theory, Practice, and Pedagogy

This theme invites critical engagement with how public administration can be reimagined through indigenous knowledge systems, cultural values, and local administrative traditions. Topics may include:

- Postcolonial critiques of administrative models in South Asia
- Culturally grounded public policy frameworks
- Indigenous practices in conflict resolution, leadership, and service delivery
- Decolonizing public administration curricula and pedagogy

Subtheme 5: Decentralization and Local Governance in South Asia

Local governance has become increasingly important in addressing regional disparities and deepening democratic practices. This subtheme explores:

- Interplay between traditional governance and formal structures

Subtheme 6: Gender, Equity, and Inclusive Public Administration

This theme invites papers that explore the theoretical foundations, institutional arrangements, and practical implications of Islamic public administration in the South Asian context and beyond. Topics may include:

- Normative frameworks of governance in Islamic traditions
- Historical models of administration in Muslim societies
- Public accountability, ethics, and leadership in Islamic governance
- Integration of Islamic administrative principles in modern bureaucracies
- Islamic philanthropy and public service delivery
- Comparative analyses of Islamic and Western administrative thought

Subtheme 9: Global Refugee and Migration Governance: Mechanisms, Crises, and Challenges

Migration and forced displacement have emerged as defining global challenges, with significant implications for public administration, human rights, and regional cooperation. South Asia, both as a source and host of migrants and refugees, is uniquely positioned within this global governance landscape. This subtheme invites papers that critically examine the institutional, legal, and policy responses to migration and refugee governance, including:

- Regional responses to refugee flows and statelessness in South Asia
- Governance mechanisms for managing cross-border migration
- The role of International Organizations in refugee protection and burden-sharing
- Migration and urban governance: challenges for local administrations
- Humanitarian governance and crisis response frameworks
- Citizenship, identity, and inclusion in migration policies
- Comparative approaches to migration governance and integration
- Ethical dilemmas and rights-based approaches in migration policy

Subtheme 10: Climate Governance and Environmental Resilience in South Asia

Climate change poses existential threats to South Asian societies, economies, and ecosystems. Effective governance is crucial for climate adaptation, mitigation, and building resilient institutions. This subtheme invites scholarly and practice-based contributions that interrogate the intersections of environmental policy, governance innovation, and local knowledge systems, including:

- National and subnational climate governance frameworks
- Integration of climate policy into public administration and planning
- Institutional capacities for climate adaptation and disaster preparedness
- Climate justice and the role of vulnerable communities
- Public-private partnerships and financing mechanisms for climate resilience
- Traditional ecological knowledge and community-led sustainability practices
- Regional cooperation for transboundary environmental governance
- Monitoring, evaluation, and accountability in climate action

Subtheme 11: Sectoral Governance and Institutional Reforms in South Asia

Robust governance systems in key public sectors—such as healthcare, higher education, water, energy, and transport—are essential for achieving equitable and sustainable development in South Asia. This subtheme invites research that critically examines sector-specific governance frameworks, institutional arrangements, reform initiatives, and public service delivery models. Emphasis is placed on context-sensitive approaches that respond to local realities while aligning with global standards. Topics may include:

- Governance of healthcare systems and public health institutions
- Reforms and challenges in higher education governance
- Public-private partnerships in service delivery across sectors
- Institutional innovations in water, sanitation, energy, and transport
- Regulation, accountability, and quality assurance in sectoral governance
- Financing, planning, and decentralization of sectoral services
- Comparative analyses of sectoral governance across South Asian countries
- Community participation and citizen engagement in sector-specific reforms

Subtheme 12: Contemporary Management Practices and Organizational Innovation

While the conference primarily focuses on public administration, management scholarship provides valuable insights into leadership, strategy, innovation, and organizational development. This general track welcomes papers from scholars and practitioners exploring evolving management paradigms across sectors, including:

- Strategic management and organizational change
- Human resource management and leadership in dynamic environments
- Innovation, entrepreneurship, and knowledge management
- Governance and performance in nonprofit and corporate sectors
- Digital transformation and the future of work
- Ethics, accountability, and stakeholder engagement
- Cross-cultural and comparative management practices
- Management education, pedagogy, and curriculum innovation

Institute of Administrative Sciences - A profile

Institute of Administrative Sciences (IAS), University of the Punjab, stands as a pioneer in public administration and management education in Pakistan.
